ORDER

As per the Government Order read as 1st paper above, Administrative Sanction was accorded for the implementation of Plan Scheme "Child Development Centre" for an amount of ₹258 Lakh under the H/A "2210-05-105-50-36(P)". As per Government Order read as 2nd, 3rd & 4th papers above, an amount of ₹1,74,15,000/- has been released so far as 1st 2nd & 3rd installment to CDC.

2. Now, the Director, Child Development Centre as per letter read as 5th paper above has requested to release the full balance amount in budget provision ie; an amount of ₹83.85 Lakh as 4th and final installment under the H/A "2210-05-105-50-36(P) for the year 2025-26.

3. Government have examined the matter in detail and are pleased to

release an amount of ₹83,85,000/- (**Rupees Eighty Three Lakh Eighty Five Thousand Only**) as the 4th & final installment for the implementation of the Plan Scheme 'Child Development Centre' under the Head of Account "2210-05-105-50-36(P)- Grant-in-Aid-General-Non Salary" from the current year's budget provision.

4. The Director, Child Development Centre shall furnish Performance cum Achievement report of the plan scheme and Utilization Certificate for the funds released with detailed item wise expenditure statement at the earliest.
