## <u>ORDER</u>

As per the Government Order read as 1<sup>st</sup> paper above, Administrative Sanction was accorded for the work - Construction of Taluk Hospital, Koothuparambu (Phase 2) for an amount of Rs.46,18,37,000/-, under NABARD RIDF Tranche XXV. Meanwhile Sanction was accorded for part Technical an amount of Rs.20,83,38,079/- for Civil Work, DG Foundation and Trench, PHE Works, Fabrication Works, Interior Works, Exterior Works and Furniture works vide Government Order read as 2<sup>n d</sup> paper above. Afterwards part Technical sanction-II was accorded for an amount of Rs.11,38,07,955/- for Electrical, Fire protection, HVAC, Lift and ELV works vide Government Order read as 3<sup>rd</sup> paper above. Furthermore, as per Government Order read as 4<sup>th</sup> paper above, Technical Sanction was accorded to the estimates of Electro-mechanical part of STP works for an amount of Rs.27,89,413/- and setting up of Medical Gas Pipeline System for an amount of Rs.1,05,09,467/-. Later, as per Government Order read as 6<sup>th</sup> paper above, Technical Sanction was accorded for the first Revised Estimate (RE 1) for an amount of Rs.46,18,19,209/-.

**2.** Earlier the site for the work - Construction of Taluk Hospital, Koothuparambu Phase 2 was handed over on 08/12/2022 with TOC period of 18 Months, which was later extended upto 07/03/2025.

**3.** The abstract of the Revised Estimate 2 for the work -Construction of Taluk Hospital, Koothuparambu (Phase 2) furnished by the SPV M/s ULCCS is as follows:
