ORDER

As per Government Order read as paper 1st above, Administrative Sanction was accorded for an amount of Rs.12,00,00,000/- for the composite work - Construction of New Block for Taluk Hospital Peringome, Kannur District with NABARD assistance under RIDF Tranche XXV (2019-20). Technical Sanction was granted for the work for an amount of Rs.11,98,18,890/-. The site was handed over on 20/08/2022, with an original completion period of one year, culminating on 12/08/2023, but due to unavoidable circumstances and the need for additional works, the completion period was later extended to

31/03/2025, and the work was fully completed within this extended time frame.

2. As per the letters read as 3rd paper above, the Chief Engineer, PWD (Buildings) informed that during execution, several deviations from the original plan and additional items of work were identified as essential to ensure the functional and operational completeness of the facility and accordingly sanction was accorded to the Revised Estimate 1 (RE I) submitted within the agreed PAC. Now, as per the said letters, the Chief Engineer, PWD (Buildings) has submitted the second Revised Estimate (RE II) for the work - Construction of New Block for Taluk Hospital Peringome, for an amount of Rs.12,65,10,900/-, which exceeded the Administrative Sanction amount. The Chief Engineer cited the reasons - quantity variation and additional works, for the said increase. The details of the Revised Estimate II furnished by the CE, PWD is as follows:

Civil Part

- Construction of the Building Rs.9,59,67,292.56/-
- Extra Item 1 Rs.50,58,473.71/-
- Extra Item 2 Rs.40,68,156.40/-
- Provision for GST 18% Rs.1,89,16,906.08/-
- Rounded total Rs.12,40,10,900.00/-

Composite part

- Civil Work Rs.12,40,10,900/-
- Electrical Work Rs.25,00,000/-
- Total RE Rs.12,65,10,900/-

The Chief Engineer, PWD (Buildings) has informed that even though the Revised Estimate 2 (RE II) amount exceeds the original Administrative Sanction amount by Rs.65,10,900/- the total bill amount would be only Rs.10,75,21,613.91/- (15.01% below Revised estimate amount) and though it exceeded the agreed amount by Rs.56,87,540.75/- the payment will be within the Administrative Sanction amount since it is a NABARD work wherein PWD have the privilege to utilize the tender savings (upto 10%). The Chief Engineer,

PWD (Buildings) also informed that the Revised Estimate as per TS rate exceeds Administrative Sanction amount and hence requested to accord Revised Administrative Sanction for the work. As per the letter read as paper 4th above, DHS has also recommended to accord Revised Administrative Sanction for the same.

- **4.** Government have examined the matter in detail. Accordingly in pursuance to the decision of the meeting of Technical Sanction Committee held on 17.06.2025, Technical Sanction is hereby accorded for Rs.12,65,10,900/- (Rupees Twelve Crore Sixty Five Lakh Ten Thousand and Nine Hundred Only) for the work Construction of New Block for Taluk Hospital Peringome, based on the Second Revised Estimate (RE 2)
- **5.** Revised Administrative Sanction is also accorded for the work for an amount of Rs.12,65,10,900/-.
