#### ORDER

The XV<sup>th</sup> Finance Commission of India has recommended an amount of ₹616.28 crore as grant-in-aid for Health Sector to be channelized through Local Governments for the year 2023-24.

2) The Director, FCD vide, letter read as 6<sup>th</sup> paper above, has conveyed the release of Health Sector Grant for 2 schemes under XV<sup>th</sup> Finance Commission amounting to ₹335.2115 crore for the FY 2023-24. It has been requested to transfer the grant-in-aid directly to the Department concerned authorized by the State Level Committee for procurement under the components detailed below:
