ORDER

1. As per Government Order read as 1st paper above, Government have issued the Kerala State Civil Supplies Corporation Common Service Recruitment Rules, 2021 governing the service conditions of the employees of the Kerala State Civil Supplies Corporation Ltd.

2. As per the judgment read as 2nd paper above, the Hon'ble High Court of Kerala has directed the Government to rectify the anomalies in the said Recruitment Rules, specifically those pointed out in Serial Nos. 3 and 8 of Ext. P4 . The Managing Director, Kerala State Civil Supplies Corporation Ltd., as per letter read as 3rd paper above, has requested the Government to issue necessary amendments in the Kerala State Civil Supplies Corporation Common Service Recruitment Rules, 2021, in compliance with the directions of the Hon'ble High Court.

3. Government have examined the matter in detail and are pleased to issue the following amendments to the Kerala State Civil Supplies Corporation Common Service Recruitment Rules, 2021, namely:-

1. Insertion of new Rule in Chapter II, Part III – General Conditions

of Service

In Chapter II, Part III – General Conditions of Service of the Kerala State Civil Supplies Corporation Common Service Recruitment Rules, 2021, after Rule 68, the following rule shall be inserted, namely:-

“68A. Rule 13B of the Kerala State and Subordinate Services Rules, 1958 shall be applicable to the employees of Kerala State Civil Supplies Corporation Ltd.”

2. Amendment to Annexure - Staff Structure, Qualification, Method of Appointment and Promotion of the Staff of SUPPYCO. –

In the Annexure relating to the Staff Structure, Qualification, Method of Appointment and Promotion of the Staff of SUPPLYCO, in item 2.6 General, in the Note below Sl.No. 3 – Junior Manager (General),

(a) The symbol and number '(i)' shall be inserted before the first sentence in the existing Note.

(b) the following condition shall be inserted, namely:-

'(iv) The percentage of appointment by Direct Recruitment through the Kerala Public Service Commission shall be limited to thirty percent (30%) and that of appointment by Promotion by Selection shall be forty percent (40%) of the total vacancies.'
