4. The district heads of other engineering departments and implementing departments shall also be included as special invitees to the Committee, depending upon the nature of works coming under consideration.

5. The terms of reference of the Committee are as follows:

i. Selection of an external agency for consultation and preparation of design and plan for the projects under packages, following all existing orders for the selection of

external agency.

ii. District Level Technical Committee headed by the District Collector is authorized to issue Technical Sanction for works under the Idukki and Wayanad Development Packages, without financial limit.

iii. To approve the revised estimate within the amount of Administrative Sanction, subject to observing all formalities.

iv. District Level Technical Committee is delegated with powers to accept the tenders, upto the powers of the Departmental Tender Committee headed by the Chief Engineer, subject to the guidelines in G.O(P) No.16/2017/Fin dated 06/02/2017.

6. The project implementation unit (PIU) is entrusted with the task of arranging the convening of the District Level Committee. To avoid procedural delays for implementation of works under the Packages, the district level officers of the concerned engineering departments are authorized to invite tenders for the work, execute the agreement, verify the bill of the works and make payment etc. within the financial limit of Chief Engineer.
