ORDER

2. Further, it has been directed that each Department shall nominate a senior-level Nodal Officer for effective coordination with the Law Department, Advocate General/Standing Counsel, State Legal Services Authority, and other concerned agencies in this regard.

3. In view of the above, Smt. Bindu C., Senior Law Officer, Directorate of General Education, is hereby designated as the Nodal Officer for the General Education Department.

The Nodal Officer is directed to identify pending cases suitable for Alternate Dispute Resolution/settlement/withdrawal in connection with the initiative and to ensure timely furnishing of instructions, authorization of competent officers for bonafide settlement decisions, and participation in pre-Lok Adalat conciliation/mediation proceedings, wherever required.

5. In the event of transfer, promotion, retirement, deputation, leave, or relinquishment of charge by the designated Nodal Officer, the duties and responsibilities assigned under this order shall devolve upon the officer succeeding to the post, until further orders are issued by Government.
