ORDER

As per the application read as 3 rd paper above, Kumari. Anupama S.P., daughter of Late Prabhukumar S, Head Accountant, Regional Transport Office, Attingal has applied for employment assistance under Compassionate Employment Scheme. Prabhukumar S, expired on 4th May, 2021 while working as Head Accountant Regional Transport Office, Attingal in Motor Vehicles Department. He had a total service of 17 years, 01 months and 9 days. As per letters read as 4th and 5th above, the Transport Commissioner and the District Collector, Thiruvananthapuram have recommended the application. No other dependent of the deceased has been given appointment under the scheme previously. All the Legal heirs of the deceased Government Servant have relinquished their claims in favour of the applicant.

2) Kumari. Anupama S.P, has passed PLUS TWO and applied for the post of Clerk. Her date of birth is 29.10.1997. The applicant opted

Thiruvananthapuram District for appointment as Clerk under Compassionate Employment Scheme. Kumari. Anupama S.P, is qualified for appointment to the post of Clerk.

- 3) Annual income of the family of the deceased Government Servant is Rs.3,24,000/-(Rupees Three lakh Twenty four Thousand only) which is within the limit prescribed in the Government Order read as 2nd paper above. The applicant satisfies all the conditions for getting employment under the Compassionate Employment Scheme in terms of the Government Order read as 1st paper above.
- 4) In the above circumstances, sanction is accorded for the appointment of Kumari. Anupama S.P, D/o, Late Prabhukumar S, Head Accountant, Regional Transport Office, Attingal as Clerk in the Motor Vehicles Department in Thiruvananthapuram district in the scale of pay of Rs.26,500-60,700/- in an existing / arising vacancy under Compassionate Employment Scheme strictly in accordance with the provisions contained in the Government Orders read as 1st and 2nd papers above.
- 5) The Transport Commissioner will issue necessary posting orders to Kumari. Anupama S.P, subject to the verification of her age, educational qualifications, character and antecedents, medical fitness etc. as per the existing orders and guidelines in the matter. The details of appointment given to the dependent should be recorded in the Service Book of the deceased employee and also in the establishment register of the office in which the deceased employee last worked.
- 6) The candidate appointed under the scheme has the option to choose any district for appointment and in case she is appointed in a district other than the district of option, she may be transferred to the district of option at the earliest opportunity without loss of seniority.
- 7) The appointment under the Scheme will be cancelled if and when it is found that there was misrepresentation or suppression of material facts on the part of the applicant, while submitting the application and thereafter.
- 8) The State Government shall have the right to cancel this order sanctioning employment under Compassionate Employment Scheme, if any records produced by the applicant is found erroneous later.
