ORDER

As per Government order read as 1 st paper above, Administrative Sanction was accorded for the Construction of Homoeo Dispensary at Vithura under the main scheme Standardization & Modernization of Homoeo Department at an estimated cost of Rs.27 Lakhs by meeting the expenditure from the provision under the Head of Account 2210-02-102-75 (plan) in the Financial Year 2019-20. Now the Director, Homoeopathy Department submitted a revised estimate for an amount of Rs.65 Lakhs and has requested to accord Revised Administrative Sanction for the above said work for an amount of Rs. 65 lakhs due to the GST hike.

2) Government have examined the matter in detail and are pleased to accord Revised Administrative Sanction for the Work "Construction of Vithura Homoeo Dispensary" for an amount of Rs. 65 lakhs under the Head of Account 2210-02-102-75 subject to the following conditions,

(i) The TS Authority shall ensure foreclosure of the previous Works / Contracts without attracting any claim for compensation to the Contractor for which the Agreement is already executed

(ii) The competent authority shall ensure the admissibility of provisions and

the correctness of the rates adopted in the Observed Data's included in the estimate with the actual site conditions before issuing the Technical Sanction.

(iii) Lump sum provisions is provided for electrification works, hence, detailed estimate shall be prepared before issuing TS and tendering.

(iv) The excavated earth shall be disposed of / reused based on the prevailing norms / rules without causing loss to the exchequer.

(v) The structural stability for constructing the retaining wall shall be confirmed and the reinforcement for the retaining wall shall be based on actual structural design, considering economy.
