ORDER

In the State budget 2026-27, a total amount of ₹ 278.29 lakh is provided to Institute for Communicative & Cognitive Neuro Sciences (ICCONS) under the non plan head of accounts, '2210-05-105-36-31-Grant-in-Aid-General Salary' (₹239.18 lakh) and '2210-05-105-36-36-Grant-in-Aid- General - Non Salary' (₹39.11 lakh), for meeting the salary and office expenses of the institute.

2. As per the Government Order read as 1st paper above, 20% of the Budget provision ie; ₹55.658 lakh, of non plan fund for the FY 2026-27, was released to ICCONS as follows;

- ₹47,83,600/- was released under the head of account '2210-05-105-36-31 - (NP) Grant-in-Aid-General Salary'
- ₹7,82,200/- was released under the head of account '2210-05-105-36-36 - (NP) Grant-in-Aid- General - Non Salary'

3. Again, as per the Government Order read as 2nd paper above, a total amount of ₹55.658 lakh was released as the second installment of non plan fund for the FY 2026-27 to ICCONS, as follows;

- ₹47,83,600/- was released under the head of account '2210-05-105-36-31 - (NP) Grant-in-Aid-General Salary'
- ₹7,82,200/- was released under the head of account '2210-05-105-36-36 - (NP) Grant-in-Aid- General - Non Salary'

4. As per the letter read above, the Director (i/c), ICCONS has requested to release the balance non plan fund amounting to Rs.166.974 lakh under the head of account 2210-05-105-36 (31 & 36), for disbursing salary for the months from August 2026 onwards, payment of gratuity which is due to the retired employees w.e.f. 30.04.2026 and incurring overhead and office expenses.

5. Government have examined the matter in detail. Sanction is hereby accorded to release a total amount of ₹87,85,565/-, as the third installment of non plan fund for the FY 2026-27 to ICCONS, as follows;

- **₹82,85,565/- (Rupees Eight Two Lakh Eighty Five Thousand Five Hundred and Sixty Five Only)** is released under the head of account '**2210-05-105-36-31 (NP) Grant-in-Aid-General Salary**' towards the salary for the month of August, Bonus and Festival Allowance and gratuity of the employees of ICCONS.
- **₹5,00,000/- (Rupees Five Lakh Only)** is released under the head of account '**2210-05-105-36-36 (NP) Grant-in-Aid - General - Non Salary**', towards electricity and other non-salary expenses.

6. The Director of Health Services, Thiruvananthapuram shall draw the amount and release the same to Director (i/c), ICCONS.
