Abstract

Home Department –High Court Establishment- Enhancement of monthly remuneration and extension of tenure for the posts of Artificial Intelligence/Machine Learning (AI/ML) Engineers and Database Administrator – Sanction Accorded – Orders issued.

ORDER

As per the Government Order read as 1st paper above, Government had accorded Administrative Sanction for the creation of two posts of Artificial Intelligence/Machine Learning (AI/ML) Engineers, with a monthly remuneration of ₹70,000/- each, and one post of Database Administrator, with a monthly remuneration of ₹50,000/-, on contract basis in the High Court, from the financial year 2026-27 onwards, for a period of one year, subject to strict observance of the guidelines issued by Government regarding contract appointments.

2.The Registrar General, vide letter read as 2nd above, informed that, considering the specialised nature of the work involved and the need to attract qualified professionals to the above posts, the Hon'ble Chief Justice had ordered that Government be addressed for revising the remuneration and tenure sanctioned for the said posts in accordance with the original proposal of the High Court. Accordingly, the Registrar General requested Government to revise the monthly remuneration of the Artificial Intelligence/Machine Learning (AI/ML) Engineers to ₹90,000/- each and that of the Database Administrator to ₹60,000/-, and also to revise the tenure of the said posts to three years from the financial year 2026-27 onwards, as proposed by the High Court.

3.Government have examined the matter in detail and are pleased to

enhance the monthly remuneration of the Artificial Intelligence/Machine Learning (AI/ML) Engineers and Database Administrator posts created in the High Court establishment from ₹70,000/- to ₹90,000/- and from ₹50,000/- to ₹60,000/-, respectively, and to extend the tenure of the said posts to three years from the Financial Year 2026-27 onwards, subject to the existing terms and conditions and strict observance of the Government guidelines governing contract appointments.
