ORDER

Sri. Jomy T.G., (Employee Code (KSEB) -1058961, Assistant Executive Engineer, Kerala State Electricity Board Limited) was appointed as Assistant Private Secretary in the personal staff of Minister for Electricity, Environment and Parliamentary Affairs vide Government order read as 1st paper above. A temporary post of Assistant Private Secretary was created in order to accommodate him in the personal staff with effect from 11/06/2026 vide Government order read as 2nd paper above. Government are pleased to order that the appointment of Sri. Jomy T.G., Assistant Private Secretary will be on deputation basis and will be regulated as per the following terms and conditions:

1. The period of deputation will be on co-terminus basis. He will be treated as on foreign service during the period of deputation.
2. He will be entitled to his grade pay in the KSE Board from time to time.
3. The pension contribution calculated @ 15% of the maximum of the scale of pay or of the elongated pay in the scale of the post from which he was deputed, will be remitted to the Board by the foreign employer.
4. Joining time will be regulated as provided in the Kerala Service Rules and joining time pay and T.A both for taking up the appointment under the foreign employer and on reversion from foreign service will be met by the foreign employer.
5. Medical facilities will be regulated in accordance with KGSMA rules.
6. Leave Salary in respect of disability leave, if any, granted to the officer on account of disability sustained by him in and through foreign service will be paid by the foreign employer, even though such disability manifests itself after the termination of the foreign service.
7. The deputationist will be eligible for T.A. as admissible under the KSRs.
8. If he takes leave on conclusion of the foreign service, but before joining in the service of the KSE Board, the difference in Leave Salary should be paid by the foreign employer.

9. The foreign employer will meet the entire leave salary for periods of leave taken while on foreign service, of the deputationist, so also the leave allowance for the earned leave surrendered while in foreign service, even though the leave is earned while in the parent department, has also to be met by the foreign employer.
10. During the period of deputation he will continue to be governed by the leave and pension rules of the parent employer applicable to him before such deputation.
11. He will be entitled to D.A, H.R.A, and other allowances as applicable to him in the KSE Board.
12. During the period of deputation he will continue to subscribe to the provident fund of the KSE Board to which he may be subscribing when he is placed on deputation in accordance with the rules of such funds.
13. He will be entitled to Leave Travel Allowance/Bonus/Ex-gratia as admissible in the KSE Board.
14. The other terms and conditions of deputation, if any, will be governed by the provisions of Chapter XI, Part I, Kerala Service Rules.
