### ORDER

As per order read as 1<sup>st</sup> Paper above, Administrative Sanction has been accorded for the construction of Kundara Pallimukku Railway Over Bridge in lieu of LC No. 526, availing funds from KIIFB and allocated Rs. 10 Cr. and RBDCK had been appointed as the Special Purpose Vehicle of the project. As per G.O read as 2<sup>nd</sup> above, revised administrative sanction had been issued for Rs 39.86 Cr.

2. As per the Order read as 3<sup>rd</sup> above, Kerala Road Fund Board had been appointed as the Special Purpose Vehicle (SPV) for the construction of a combined ROB and Flyover at Kundara Pallimukku-Junction subsequent to which, RBDCK had withdrawn the Land Acquisition request submitted to the District Collector.

3. As per the decision taken in the meeting held on 27.01.2024, RBDCK requested to reissue the previous order by appointing RBDCK as SPV to take up the Construction of Kundara Pallimukku ROB, provided that the work shall be taken up after re-validation of financial sanction by KIIFB.

4. CEO, KIIFB informed, vide letter read as 4<sup>th</sup> above, that RBDCK may once again be designated as the SPV and RBDCK may be advised to submit a rough cost estimate of the project after obtaining the expansion plan from Railways, for issuing revised Administrative Sanction. As per the letter read as 5<sup>th</sup> above, the General Manager, RBDCK has furnished a rough cost estimate of the project of Rs 43,32,64,240/-.

5. Government have examined the matter in detail and are pleased to accord revised administrative sanction for an amount of Rs 43,32,64,240/- (Rupees Forty Three Crores Thirty two lakhs sixty four thousand two hundred and forty rupees only) by availing fund from Kerala Infrastructure Investment Fund Board (KIIFB) for the construction of Kundara Pallimukku ROB in lieu of LC No. 526 in

Kollam District. The Roads & Bridges Development Corporation of Kerala Ltd. (RBDCK) has been designated as the Special Purpose Vehicle (SPV) for executing the project.
