## **ORDER**

As per the Government Order read as 1st paper above, Administrative Sanction was accorded for an amount of ₹351,48,03,778/- for the Wayanad Township Project, comprising 410 residential units, Public buildings, internal roads, water supply and sewage systems, electrical infrastructure, and allied works.

- 2) As per the Government Order cited as 2nd above, Technical sanction was accorded by KIIFCON for an amount of ₹324,49,97,064, and after negotiations, the EPC contract amount was finalized at ₹299 Crore, inclusive of GST, and agreement was executed accordingly.
- 3) Among the Wayanad Township Project components, the residential units and associated services are funded under the Chief Minister's Distress Relief Fund (CMDRF), while the construction of roads, public buildings, and amenities in the township at Elston Estate is

funded under SASCI.

4) As per the 4th paper read as above, Ministry of Finance has approved the project submitted by the State under SASCI and released an amount of Rs. 529.50 crore under Part-I (Untied) of SASCI 2024-25.

- 5) As per the Letter cited 3rd above, the Special Officer, Wayanad Township Project has requested to release the SASCI component amounting to ₹95,12,85,435/- to the dedicated SASCI bank account of the Project Implementation Unit (PIU), Wayanad Township Project.
- 6) The total amount for the SASCI-funded components of the Wayanad Township Project comes to ₹95,12,85,435/-, and the centage charges for the employer's contractor at 4.5% applicable for these works is also to be met from the SASCI fund, as detailed below.
