ORDER

Administrative Sanction was accorded for Rs.184.98 crores for the implementation of one year running contract for the maintenance of roads comprising Cluster II (cluster II -Moderately damaged road stretches) in all 14 Districts of the State under the H/A 3054-03-337-99 (NP) vide Government Order read as 1st paper above.

2. Accordingly, Technical Sanction was accorded for the work "GENERAL-RM-2022-23/CLUSTER II/One year RC- Zone XIV- for various PWD Roads under Roads section Karimannoor in Idukki District - 3 roads stretches for a length of 16.450 km" for an amount of Rs. 55.25 lakh.

3. The Chief Engineer, PWD Roads Division, Thiruvananthapuram, vide letter read as 2nd paper above, has requested government to accord Revised Administrative Sanction for the work "GENERAL-RM 2022-23/CLUSTER II/ One Year RC-Zone XIV-For various PWD Roads under Roads Section- Karimannoor in Idukki District -3 Roads stretches for a length of 16.450 Km" for an amount of Rs Rs.58.44 lakh (Rupees Fifty Eight Lakh and Forty Four Thousand Only) in the h/a 3054-03-337-99 (NP).

4. Government have examined the matter in detail and are pleased to accord

Revised Administrative Sanction for the work "GENERAL-RM-2022-23/CLUSTER II/One year RC- Zone XIV- for various PWD Roads under Roads section Karimannoor in Idukki District -3 roads stretches for a length of 16.450 km" for an amount of Rs.58.44 lakh (Rupees Fifty Eight Lakh and Forty Four Thousand Only) as per TS rate including 18% GST, in the h/a 3054-03-337-99 (NP) subject to the following conditions against the original Administrative Sanction of ₹55.25 Lakhs:-

1. The agreed PAC amount shall not be increased, in any case and the increase in expenditure shall only be due to increase in GST component. Directions in the Circular No. 79/2022/FIN dated 15-09-2022 shall be strictly followed for allowing increased GST rate.
2. Since the work was already completed, TS authority shall confirm and satisfy himself that the execution of excess quantity of existing items and extra items were unavoidable and necessary as per the site conditions prevailed at that time.
3. TS authority shall not allow any more changes / increase in quantities in the revised estimate.
