### **ORDER**

Following the recommendation of the National Human Rights Commission and the Final order of the Hon'ble Supreme Court of India in WP(C) 213/2011 read as 6th paper above, Government accorded sanction to disburse compensation to all Endosulfan victims in a time bound manner.

2. The Hon'ble Supreme Court of India in its Final Order in WP(C) 213/2011 specifically noted that, it shall be open for the State Governments to recover the aforesaid compensation either from the concerned industry or from the Government of India, in case it is open to the state governments to make such recovery, in consonance with law.

3. Accordingly as per Government Order read as 7th paper above, Agriculture Department in Government authorised the District Collector, Thiruvananthapuram to file a Civil Suit against the manufacturers of endosulfan and other concerned organisations/institutions who supplied endosulfan to Plantation Corporation of Kerala Limited for realizing the amount paid towards the rehabilitation and Welfare of the endosulfan victims in Kasargod District, for and on behalf of State of Kerala. Accordingly, the District Collector, Thiruvananthapuram has filed an Original Suit. No. 2/2019 before the Sub Court, Thiruvananthapuram (Additional Sub Judge, Trivandrum). The above case is still pending disposal.

4. Government examined the matter in detail and are pleased to constitute a team of officials for the proper conduct of the Original Suit. No. 2/2019 filed before the Sub Court, Thiruvananthapuram (Additional Sub Judge, Trivandrum), to co-ordinate its conduct, and to codify the opinion of experts to be tendered in evidence for properly assessing and fixing the liability of the manufacturers.
