ORDER

As per the Government letter read as 1st paper above sanction was accorded to the Managing Director,Kerala State Electronic Development Corporation Ltd (KSEDC) to appoint an Executive Director in the company. Accordingly Shri.Hemachandran.S has been appointed as the Executive Director of the KSEDC on contract basis for a period of 2 years with a consolidated remuneration of Rs.75,000/- per month.

2)As per the Government Order read as 2nd paper above, his contract period was extended for a further period of 2 years with effect from 04/04/2024, with a revised remuneration of Rs.1.10 lakh per month with 5% annual increment.

3)The Managing Director, KSEDC, as per the letter read as 3rd paper above has requested to extend the tenure of Shri.Hemachandran.S as Executive Director of KSEDC on contract basis for a further period of 2 more years on the existing terms & conditions, w.e.f.04/04/2026, with an enhanced remuneration of Rs.1.35 lakhs per month.

4) Considering his contributions & expertise required in the area of Power Electronics, Space Sector, GIS Sector and overall contribution in Research & Development wing of Keltron, the Board of Directors of the company has also recommended the proposal.

5) The Board for Public Sector Transformation (BPT), as per the letter read as 4th paper above has also recommended the extension of tenure of Shri.Hemachandran.S for a further period of 2 years and also recommended the remuneration as proposed by KSEDC.

6) Government have examined the matter in detail and are pleased to accord sanction for the extension of tenure of Shri.Hemachandran.S as Executive Director in KSEDC for a further period of 2 years on contract basis on the existing terms & conditions, with effect from 04/04/2026, with an enhanced remuneration of Rs.1.35 Lakhs per month.
