ORDER

Parassinikadavu-Mayyil Road is a significant transportation artery in Kannur District and plays a vital role in promoting tourism. Sree Muthappan Temple, Parassinikadavu is a major Tourism attraction along this road. The road connects major tourist destinations, making travel convenient and Parassinikadavu-Mayyil Road can become a thriving tourism corridor, showcasing Kannur's natural beauty, culture and hospitality. Therefore it is imperative to beautify the road comprehensively to enhance its potential as a sustainable tourism spot.

2. Subsequently, the Director of Tourism as per letter read above has submitted a project proposal 'Parassinikadavu Road Beautification Works, Kannur' to the tune of ₹ 2,84,00,000/-(Two Crore Eighty Four Lakh only) with the following components before the Departmental Working Group Meeting:-

Government have examined the matter in detail and are pleased to accord sanction to the Director of Tourism to expend an amount of ₹2,84,00,000/-(Two Crore Eighty Four Lakh only) including GST for the project 'Parassinikadavu Road Beautification Works, Kannur' by meeting the fund available under the Head of Account 5452-01-101-99-00-34-03 Up gradation, Creation of Infrastructure and Amenities(Plan) subject to the following conditions:
- i). The work shall be implemented in non-PMC manner.
- ii). All clearances including CRZ clearances shall be obtained.
- iii). Separate TS shall be taken for electrification works.
- iv). Detailed Estimate should be approved for all the items to which lumpsum provision is provided in the estimate.
- v). Time of completion of work will be 18 months.
- 5. The Director of Tourism shall ensure that all the procedural and codal formalities and the conditions stipulated in the Government Order read as paper above shall be strictly adhered to.
