<u>ORDER</u>

As per the Government Order read as 1st paper above Government have accorded Administrative Sanction to the Registrar of Co-operative Societies, Thiruvananthapuram to implement the project, viz., 'Setting up of a Modern Rice Mill Processing (MRMP) unit in Pampadi Block of Kottayam District of Kerala' for an eligible Total Financial Outlay of Rs.80 Crore (Rupees Eighty Crore Only) with RIDF loan of Rs.76 Crore (Rupees Seventy Six Crore Only) and State Government share of Rs.4 Crore (Rupees Four Crore Only).

2. As per the letter read as 2nd paper above the Registrar of Co-operative Societies has reported that the Rs.4 Crore (out of the Total Financial

Outlay of Rs.80 Crore and which is mentioned as State share in the Government Order 1st read above), will be met from the own funds of the Kerala Paddy Procurement Processing & Marketing Cooperative Society Ltd No.4505 (KAPCOS) Kottayam.

Government have examined the matter in detail and are pleased to order that the Rs.4 Crore (Rupees Four Crore Only), (out of the Total Financial Outlay of Rs.80 Crore and which is mentioned as State share in the Government Order 1st read above), will be met from the own funds of Kerala Paddy Procurement Processing & Marketing Cooperative Society Ltd No.4505 (KAPCOS) Kottayam, and that the words "State Government share of Rs.4 crore (Rupees Four Crore)" appeared in the Para 3 of the Government Order 1st read above stood deleted.
