**ORDER**

The Director of Malabar Cancer Centre (MCC ), as per letter read as first above has informed that , Malabar Cancer Centre (Postgraduate Institute of Oncology Sciences and Research) has applied for seeking accreditation with NBE (National Board of Examinations) in the specialty of Anesthesiology. But the applicant Hospital (MCC-PGIOSR) does not have adequate exposure in the areas of Cardio Thoracic and Vascular Surgery (CTVS), Cardiac Cath lab which are essential for the said purpose. Also as per the NBE requirement, comprehensive training shall have to be provided by the Hospital (MCC-PGIOSR). Hence MCC-PGIOSR requested to have an MoU (Memorandum of Understanding) with Government Medical College, Kannur, where the above-mentioned exposure is available. As per the proposed MoU, Trainees of the applicant Hospital shall have rotational posting in the areas of CTVS, Cardiac CATH Lab etc and hence the Director, MCC has requested to take favorable steps in this regard. The Director of Medical Education, as per letter read as second above, has informed the willingness to sign an MoU between Malabar Cancer Centre - Postgraduate Institute of Oncology Sciences and Research (MCC-PGIOSR)

and the Government Medical College, Kannur for the aforementioned purpose.

2. Government examined the matter in detail and are pleased to accord sanction to sign Memorandum of Understanding between Government Medical College, Kannur and MCC-PGIOSR for Accreditation with NBE in the specialty of Anesthesiology subject to the condition that the posting of trainees from MCC- PGIOSR shall not affect the training of students of Government Medical College, Kannur.

3. The Director of Medical Education will take further necessary action in the matter.
