ORDER

Administrative Sanction was accorded for the proposal for setting up of Design Studios at Kochi and Thiruvananthapuram under the scheme Modernisation and Promotion of value added products, for an amount of Rs.55,00,000/-(Rupees Fifty Five Lakh only) by debiting the amount under the head of account 2851-00-103-33(P) from the current year's budget provision and limiting the amount within 50% of the overall allocation of Industries Department as per plan prioritization, vide Government Order read above.
