ORDER

As per Government order read as 5th and 6th papers above, the first and second installment of funds under the scheme National Mission for Natural Farming(NMNF) for FY 2025-26 under General, SCP and TSP category were released. Now as per letter read as 7th paper above, Government of India has accorded mother sanction in SPARSH for an amount of ₹168.40 lakhs being third installment Central share. The category wise split up of funds under various categories for the scheme along with the corresponding State is as follows:

2. The fund released is for implementation of the activities approved under AAP for the year 2025-26 through SNA SPARSH. The Director of Agriculture as per letter read as 8th paper above has informed that there is no budget provision under any of the heads for the NMNF component and hence requested for additional authorization to the concerned state heads . As per Government order read as 9th paper above, an amount of **₹280.67 lakhs** (Rupees Two Crore Eighty Lakh Sixty Seven Thousand only) was additionally authorised to facilitate the release of the third installment of the General, SCP, and TSP components of the Scheme, National Mission for Natural Farming (NMNF) 2025-26. .

3. Government have examined the matter in detail and are pleased to accord sanction to release a total amount of **₹2,80,67,000/-** (Rupees Two Crore Eighty Lakh Sixty Seven Thousand only) as **third installment** of funds for implementation of the Scheme, National Mission for Natural Farming(NMNF) 2025-26 through SNA SPARSH as detailed in table below :
