ORDER

The Ministry of Rural Development (MoRD), GoI, vide letter read as 2nd paper above, had sanctioned an amount of ₹19,74,20,000/- as 2nd instalment of Central share Mother Sanctioned under SNA SPARSH for the year 2025-26 for the implementation of SVEP umbrella projects in the State. Being the implementing agency of SVEP in Kerala, the Executive Director, Kudumbashree, as per the letter read as 3rd paper above, has requested to release a total amount of ₹32,90,33,333/- including matching State share ₹13,16,13,333/-, after getting additional authorization to the corresponding head of account.

2. Government have examined the matter in detail. As per GO read as 4th paper above, an additional authorization of ₹32,90,34,000/- has been sanctioned. In the above circumstances, Government are pleased to accord sanction to release an amount of ₹32,90,33,333/- (Rupees Thirty Two Crore Ninety Lakh Thirty Three Thousand Three Hundred and Thirty Three only) towards 2nd instalment of the Central share and its

matching State Share for the year 2025-26 for the implementation SVEP umbrella projects in the State from the current year budget by debiting the head of account 2501-06-198-48-16.

3.The conditions/guidelines/procedures stipulated in the Circular read as 1st paper above and the letter read as 2nd paper above should strictly be followed and complied with. The controlling officer concerned should take timely steps to regularize the additional authorization as per GO read as 4th paper above through Re-appropriation of Savings only within the Grant before the close of the current financial year.
