ORDER

As per the Government order read as 1st paper above, Administrative Sanction for an amount of Rs.74,55,800/- has been accorded for the research project "New Born Screening for Severe Inborn Errors of Immunity – A Pilot Study - Phase II" under the head of account '2210-05-001-93-36 (P) – Grant-in-Aid-General Non Salary' from 2024-25 years budget provision. The Registrar, KUHS vide letter read as 2nd paper above has reported that the research work "New Born Screening for Severe Inborn Errors of Immunity – A Pilot Study - Phase-I" has been completed and IInd phase of work is in the initial stage and hence it is requested to grant 80% of the Administrative Sanction amount ie; an amount of Rs. 59,64,640/

urgently for the continuation of the research work.
