### ORDER

1) In pursuance to the instruction of Election Commission of India, Government have ordered ‘Cashless Treatment Scheme’ as per Government Order read as 1st paper for providing immediate medical assistance to all polling/ security personnel in the nearest Government or Private Hospital on emergency such as accident, cardiac arrest, stroke etc happens while deployed for election duty of all General/ Bye

Elections. As per the letter read as 2nd paper, the Election Commission of India has directed to make arrangements for treatment in state-of-the-art hospitals for all such personnel involved in elections who get injured or fall sick while on election duty.

2) As per the letters read as 3rd paper above the District Election Officer, Malappuram has reported that Sri. Lavakush, Police Constable, 274/574-F COY, VSSC Thumba CAPF, deployed for security duties in connection with Bye election to Wayanad HPC, who resided at MSP Nilambur Camp with his troop, on 31.10.2024 evening, met with medical emergency as he suffered acute chest pain associated with sweating. He was brought to Govt. Hospital Nilambur and then shifted to Aster Mother Hospital Areekode for better medical care. It is reported that he had underwent angioplasty at the hospital and discharged on 04.11.2024 in a stable condition with medications. As per the Patient Bill read as 5th paper, the total amount incurred for the treatment of Sri.Lavakush, Police Constable at Aster Mother Hospital, Areekode is Rs. 1,77,146/- (One Lakh Seventy Seven Thousand One Hundred and Forty Six only).

3) The District Election Officer, Malappuram has recommended and forwarded the Inpatient Bill of amount ₹ Rs. 1,77,146/- (One Lakh Seventy Seven Thousand One Hundred and Forty Six only) in respect of treatment of Sri. Lavakush, Police Constable for payment. The District Police Chief, Malappuram has certified that Sri. Lavakush, had sought medical treatment after falling ill during his security duty in connection with the Bye Election to Wayanad HPC.

4) Government have examined the matter in detail and are pleased to accord sanction for the payment of hospital bill amounts to ₹ Rs.

1,77,146/- (One Lakh Seventy Seven Thousand One Hundred and Forty Six only) incurred for the treatment of Sri. Lavakush, Police Constable, 274/574-F COY, VSSC Thumba CAPF, who was fell ill while on election duty in connection with Bye Election to Wayanad HPC, 2024.

5) The District Collector & District Election Officer, Malappuram will make immediate arrangements to release the amount of assistance. The expenditure in this regard will be met from the provisions under the head of account "2015-00-105-99-34-OC".
