ORDER

Government of Kerala have decided to give an amount of Rs.10,00,00,000/- (Rupees Ten Crore only) as financial assistance to the earthquake victims of Turkey / Syria and the decision was communicated to the Ministry of External Affairs, Government of India as per the letter read as 1st paper above.

2. As per the letter read as 2nd paper above, the Secretary(west), Ministry of External Affairs, Government of India have informed that the said amount may be sanctioned to the account of Ministry of External Affairs and that the Ministry of External Affairs will make that amount/ material of corresponding value available to Turkey/Syria, stating the same as a goodwill gesture from Government of Kerala.

3. As per Government order read as 3rd paper above, an amount of Rs.10,00,00,000 (Rupees Ten Crore only) has been authorised as additional expenditure under the Head of Account 2075-800-82-(01)-Financial Assistance to earthquake hit Turkey and Syria (NP), subject to the condition that the additional expenditure should be regularised through Re-appropriation of Savings within the Grant/Supplementary Demands for Grants before the close of the current financial year. The Secretary(west), Ministry of External Affairs has also

shared the account details as per the letter read as 4th paper above.

4. In the circumstances, Government are pleased to accord sanction for the release of Rs.10,00,00,000/- (Rupees Ten Crore only) to the account mentioned below for disbursing the same as financial assistance to the earthquake victims of Turkey / Syria as a goodwill gesture from Government of Kerala:-
