### **ORDER**

As per Government Order referred as 1<sup>st</sup> paper above, Government have restructured the Kerala Development and Innovation Strategic Council(K-DISC) as a society under the Travancore-Cochin Literary, Scientific and Charitable Societies Registration Act, 1955 with a Governing Body headed by the Chief Minister and an Executive Committee headed by the Finance Minister. Accordingly, the Kerala Development and Innovation Strategic Council (K-DISC) has been registered as a society. The K-DISC was given an enhanced mandate on innovation promotion and knowledge building.

2) In the Kerala State budget 2024-25, an amount of Rs. 23 crores (Rupees Twenty-Three Crores Only) has been earmarked for various projects/activities of Kerala Development and Innovation Strategic Council (K-DISC) under the following plan schemes and heads:

3) The Member Secretary, K-DISC, in the letter cited as 6 <sup>th</sup> above, has informed that the Eleventh Meeting of the First Executive Committee, chaired by the Minister for Finance held on 29.05.2024 including the Additional Chief Secretary, Planning &Economic Affairs Department and Principal Secretary, Finance Department, which has the powers of Special Working Group, has scrutinized the submitted proposal of plans for the financial year 2024-25 with a total outlay of Rs. 275 crores for implementing ongoing/continuing schemes as envisaged by the Kerala State Budget and the Budget Speeches from 2021-22 on wards. The Executive Committee has approved and recommended Administrative Sanction for an outlay of Rs. 225 crores for all activities under the two on going schemes, as detailed in table-2 and 3 below, for implementation during the financial year 2024-25 subject to pruning of scope and expenditure by the three member Expert Committee constituted for the purpose by the Member Secretary, K-DISC:

- 6) The Government after having examined the proposal in detail and are pleased to accord Administrative Sanction to the Kerala Development and Innovation Strategic Council (K-DISC) for a total amount of Rs. 21287.325 lakh including the balance Plan outlay of Rs.1087.325 lakhs under the two ongoing schemes viz 'Innovation Challenge Fund' (Rs. 6957.545 Lakh) and Knowledge Economy Fund (Rs. 14329.78Lakh) being the balance Administrative Sanction for the financial year 2024-25 as per Table-5 above for implementing all the programmes /components as detailed in Table-2 and Table-3 above subject to pruning of expenditure by the three member Expert Committee constituted for the purpose by the Member Secretary , K-DISC . Also observing all relevant rules and procedures in force and subject to the conditions stipulated hereunder.

  - ii. The fund release will be based on actual requirement.
  - iii. Store Purchase Rules shall be strictly adhered to.
- iv. Tender/e-Tender and other stipulated formalities shall be followed wherever necessary.

- v. For civil works, CPWD specifications and rates as per Price Schedule shall be followed.
  - vi. Post creation and purchase of vehicles are not admissible under the scheme unless specifically sanctioned by Government.
