- They and their family members will not be eligible for any of the benefits exclusively intended for members of the Scheduled Tribes. If they are availing any benefits meant for members of the Scheduled Tribes, all such benefits should be stopped.
- If the caste in respect of Shri. Bhagavati Ayyappan, Shri. Murukan B., Shri. Murali B., Smt. Ajitha R. and Shri. Ayyappan B. and their family members is recorded in their academic records as Scheduled Tribe (Malavedan), it should be got corrected as Thottiyan community.
- Scheduled Tribe Certificates will not be issued to them or their family members hereinafter. All the Scheduled Tribe Certificates secured by them and their family members, are treated as cancelled.
- If they or their family members got appointment/admission on consideration as member of Scheduled Tribe community, they should be terminated from service/admission should be cancelled and another eligible member of the Scheduled Tribe community shall be appointed/admitted against the resultant vacancy.

3. Compliance report on the above orders will be furnished to Government by all concerned, at the earliest.
