ORDER

The Scrutiny Committee for verification of Community Certificates, constituted under the Kerala (Scheduled Castes and Scheduled Tribes) Regulation of Issue of Community Certificates Act, 1996, as per Proceedings read above, rejected the Scheduled Tribe (Ulladan) claim of Smt. Ligi K.P., D/o.Vijaya, Kattungal (H), Kareppadam, Kuttichira P.O., Thrissur district and recommended Government to take further action to issue orders in this regard.

- 2. Government have accepted the above recommendation and the Scheduled Tribe (Ulladan) claim of Smt. Ligi K. P., D/o.Vijaya, Kattungal (H), Kareppadam, Kuttichira P. O., Thrissur district is hereby rejected with clarification on the following:
- 1. Smt. Ligi K. P., D/o.Vijaya, Kattungal (H), Kareppadam, Kuttichira P. O., Thrissur district does not belong to Scheduled Tribe (Ulladan) community, but to Christian Roman Catholic Community.
- 2. She will not be eligible for any of the benefits exclusively intended for members of the Scheduled Tribes. If she had availed any such benefits meant for members of the Scheduled Tribes, all such benefits should be stopped.
- 3. If the caste in respect of Smt. Ligi K. P., D/o.Vijaya, Kattungal (H), Kareppadam, Kuttichira P. O., Thrissur is recorded in her academic records as Scheduled Tribe (Ulladan), it will be got corrected as Christian Roman Catholic Community.
- 4. Scheduled Tribe Certificates will not be issued to her hereinafter. All the Scheduled

Tribe Certificates secured by her are treated as cancelled.

5. If she got appointment or admission on consideration as member of Scheduled Tribe community, she should be terminated from service or her admission should be cancelled and another eligible member of the Scheduled Tribe community shall be

appointed/admitted against the resultant vacancy.

3. Compliance report on the above orders will be furnished to Government by all

concerned, at the earliest.
