ORDER

The Scrutiny Committee for verification of Community Certificates as per Proceedings read as 2nd above rejected the Scheduled Tribe (Malai Arayan) claim of Dr. Aiswarya T. Thomas, Kum. Aswathy T. Thomas, Kum. Anaswara T. Thomas, D/o. Late. Thomas John, Thekkekkara, Karukachal P.O., Kottayam district and recommended Government to take further action in this regard.

- 2. Government have decided to accept the above recommendation and the Scheduled Tribe (Malai Arayan) claim of Dr. Aiswarya T. Thomas, Kum. Aswathy T. Thomas, Kum. Anaswara T. Thomas, D/o. Late. Thomas John, Thekkekkara, Karukachal P.O., Kottayam district is hereby rejected with clarification on the following:
 - Dr. Aiswarya T. Thomas, Kum. Aswathy T. Thomas, Kum. Anaswara T. Thomas, D/o. Late. Thomas John, Thekkekkara, Karukachal P.O., Kottayam district do not belong to Scheduled Tribe (Malai Arayan) community, but to Scheduled Caste converted to Christianity, which is included in the OBC list of the State.
 - They are not eligible for any of the benefits exclusively intended for the members of the Scheduled Tribes. If they had availed any benefits meant for members of the Scheduled Tribes, all such benefits should be stopped.
 - If the caste in respect of Dr. Aiswarya T. Thomas, Kum. Aswathy T. Thomas, Kum. Anaswara T. Thomas is recorded in their academic records as Scheduled

Tribe (Malai Arayan), it should be got corrected as Scheduled Caste converted to Christianity.

- Scheduled Tribe certificates will not be issued to them hereinafter. All the Scheduled Tribe certificates secured by them are treated as cancelled.
- If they got appointment/admission on consideration as member of Scheduled Tribe community, they should be terminated from service or that should be cancelled and another eligible member of the Scheduled Tribe community shall be appointed/admitted against the resultant vacancy.
- 3. Compliance report on the above orders will be furnished to Government by all concerned, at the earliest.
- 4. The Judgment dated 06.10.2020 of the Hon'ble High Court of Kerala in W.P. (C) No.1010/2020 is thus complied with.
