ORDER

As per the letter read above, the Chief Engineer (Buildings), Public Works Department, Thiruvananthapuram had submitted proposal for Administrative Sanction for the work "Renovation of playground and swimming pool at Govt. college Kozhinjampara" in Palakkad district with a detailed estimate for an amount of

Rs.200 Lakhs under the Head of Account 4059-01-051-86 based on the DSR 2018 and 18% GST.

2) Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work - "Budget 2024-25" - renovation of playground and swimming pool at Govt. college Kozhinjampara in Palakkad district" for an amount of Rs. 200 lakhs under the Head of Account 4059-01-051-86(P) subject to the following conditions :

a) Since, lump sum provision of Rs. 9,00,000/- is provided for general electrification, hence detailed estimate for the same shall be prepared before issuing Technical Sanction.

b) An amount of Rs. 87,34,664.74/- is provided for “Appendix- A: Gallery works”, hence it is opined that, adequate entry and exit points shall be provided for meeting emergency situations and structural

stability of the Gallery shall be ensured by the TS authority before according TS.

c) An amount of Rs. 3,45,499.35/- is provided for “Appendix-D: Bore well”, hence it is opined that, the TS authority shall ensure the rates and specification adopted shall confirming with the Guidelines laid down by Ground Water Department.

d) The correctness of the rates adopted for observed data’s included in the estimates shall be ensured by the TS authority.

e) Proper Technical Sanction shall be issued by the competent authority after ensuring the admissibility of provisions included in the estimate with the site conditions before issuing the Technical Sanction.

3)The Chief Engineer,PWD Buildings shall ensure that the aforesaid conditions are adhered to.
