ORDER

The Chief Engineer (Roads) as per his letter read above has furnished an estimate report for the work 'General - Budget Work 2024-25 - Improvements to various Village roads in Ranny LAC - Ranny LAC - General Civil Work' amounting to ₹700/- Lakhs for Administrative Sanction under head of account '5054-04-337-97-ODR'.

- 2. Government have examined the matter in detail and are pleased to accord Administrative Sanction for the work "General Budget Work 2024-25 Improvements to various Village roads in Ranny LAC Ranny LAC General Civil Work" in Ranni LAC for an amount of ₹700 Lakhs (Rupees Seven Crore Only) under the Head of Account '5054-04-337-97-ODR', subject to the following conditions:
 - i. The TS authority shall verify the requirement and necessity of WMM/ GSB provisions, pothole filling proposed with 36mm

metal & 12mm metal along with levelling course provisions proposed as per the actual site requirement before issuing Technical Sanction in all the works.

- ii. In addition to that the TS authority shall specifically review the requirement of road concreting proposed for the entire length and width of the two roads-Sl No.2 RANNY SECTION-Marthomappallyppady-Punchirimukku Road in Pazhavangaadi GP & Sl No.3 RANNY SECTION- Anjilimukku-Kochukulam-Thekkekara road in Naranamoozhy GP before issuing Technical Sanction.
- iii. TS authority shall also review the 40mm MSS bituminous "S1 No.9, RANNY surfacing proposed for SECTION-Anthyalankavu Kanamukku Road in Cherukol GP& Sl No.18, LAHA SECTION-Pezhumpara-10th block road in Vadasserikkara", keeping in backdrop the traffic density and which has a carriageway width of only 3m (same as that for other 13 roads).
- iv. The WMM provision / drainage provision / pothole filling / & levelling course provisions provided for Sl No.8 RANNY SECTION-Kudilumukku-Pandalam mukku Road in Cherukol GP, Sl No.9 RANNY SECTION-Anthyalankavu Kanamukku road in Cherukol GP, Sl No.11 RANNY SECTION-Pathiyaanpady-Changelpady Road in Cherukol GP & Sl No.13 VENNIKULAM SECTION- Vellayilkunnam- Challappally Roads shall be reviewed and regulated by the TS authority before issuing technical sanction.
- v. The provisions of dismantling of the existing concrete and reconcreting shall be reviewed and modified to suit the site conditions.
- vi. TS authority shall ascertain the chainages, nomenclature of the

works, width of carriageway and chainages are noted for various provisions.

- vii. TS authority shall visit the site for all the work and ensure that the provisions are reasonable and work specific before issuing Technical Sanction.
- viii. The additional cost due change to DSR 2021 shall be met from the savings obtained during review of estimate provisions as noted above while issue of Technical Sanction.
