### ORDER

As per the letter read above, Member Secretary, Kerala State Disaster Management Authority( KSDMA) has informed that Tsunami Ready Program has been initiated in nine coastal districts of Kerala. This program aims to enhance the preparedness and resilience of communities through capacity building and systematic interventions. As part of this initiative, the Kerala State Disaster Management Authority (KSDMA) conducted a state-level consultation meeting at Thiruvananthapuram and pre-planning meetings at the selected 9 coastal Grama Panchayats under the Tsunami Ready Program. To achieve "Tsunami Ready" certification for participating Panchayats, KSDMA requires funding to fulfil the program's 12 key indicators. These funds will support various activities, including Panchayat-level initiatives, preparation of Evacuation Maps & Plans, University involvement, training programs, public awareness campaigns, installation of signage and information boards, and mock drills. Member Secretary, Kerala State Disaster Management Authority has requested to release an amount of Rs.37,05,000/- from SDRF for the implementation of the Tsunami Ready Program in Kerala.

Government have examined the matter in detail and are pleased to

release an amount of Rs.37,05,000/- (Thirty Seven lakh five thousand only) to Member Secretary, KSDMA from the head of H/A 2245-02-101-94-01-Flood other items under SDRF for the implementation of the Tsunami Ready Program in Kerala.
