- 3) The tuition fee, special fee and other eligible fees in respect of SC/ST/OEC students admitted for the course in 2024-25 will be sanctioned to the college by the Director of SC/ST Development Department at the rates fixed by the Fee Regulatory Committee for Medical Education in Kerala.
- 4) The fee fixed by the Fee Regulatory Committee as detailed above shall be the fee for the entire period of the course of 2024-25 batch. Any change regarding the ownership of management of the institutions during the entire period of the course will not affect the fee fixed by the Fee
