ORDER

The Seniority List of Deputy Commissioners of Excise has been finalized upto 31.08.2022 and final Seniority List of Deputy Commissioners of Excise for the period from 01.07.2021 to 31.08.2022 has been published as per the order read as 1st paper above. Thereafter, Select List of Assistant Commissioners of Excise for promotion to the cadre of Deputy Commissioners of Excise for the year 2023 has been prepared by the Departmental Promotion Committee (Higher) meeting held on 28.02.2023, including only 3 officers, viz. S/Sri. Sojan Sebastian, Ragesh T., and Sunu C., and the same has been approved and published by the Government as per the Government Order read as 2nd paper above. Subsequently, they have been promoted to the cadre of Deputy Commissioner of Excise, details of which is shown in Table-1 below. But, Seniority List of Deputy Commissioners has not been prepared for the period after 31.08.2022 and hence the above 3 officers have not been included in any seniority list of Deputy Commissioners of Excise.

Sri. Teny Mon B. has been given notional promotion in the cadre of Assistant Commissioner, as per G.O.(Rt) No. 903/2022/Taxes dated 22.11.2022, with effect from 30.03.2021. He was later included in the seniority list of Assistant Commissioner for the period from 01.09.2019 to 31.03.2021 as Sl. No. 22A below Sri. Sunu C. as per Order No. EXC/1675/2022-XD3 dated 01.04.2023 of Excise Commissioner.

2. The Seniority List of Assistant Commissioners of Excise for the period from 01.04.2021 to 31.12.2022 has been finalized and published as per the order read as 3rd paper above. The Ad hoc Departmental Promotion Committee (Higher) of the Excise Department, which met on 19.12.2024, has prepared the Select Lists of Assistant Commissioners of Excise for promotion to the cadre of Deputy Commissioners of Excise for the years 2023 (Supplementary) and 2024. These Select Lists has been approved and published by the Government as per the Government Order read as 5th paper above.

3. 9 number of Assistant Commissioners of Excise, as detailed in Table-2 below, who were included in the supplementary select list of Assistant Commissioners of Excise for the year 2023 and select list for the year 2024 were given temporary promotion to the cadre of Deputy Commissioners of Excise under Rule 31(a)(i) of KS&SSR's. Among these officers, Sri Rakesh.M has been superseded by the DPC(H) meeting held on 19.12.2024 and hence cannot be considered for promotion to the cadre of Deputy Commissioner of Excise. Also, Sri Vinodkumar.S has been included only provisionally as per note(i) of rule 28(b)(i)(7) of KS&SSR's and hence he can be promoted to the cadre of Deputy Commissioner of Excise only provisionally.

4. 9 vacancies of Deputy Commissioners of Excise are at present lying vacant in Excise Department. Also, one vacancy of Joint Commissioner is anticipated against the creation of a deputation post of Joint Commissioner of Excise as Technical Officer in the Kerala Toddy Industry Development Board, as per G.O.(Ms) No. 74/2024/Taxes dated 16.11.2024. Supplementary select list of Deputy Commissioner of Excise

for promotion to the cadre of Joint Commissioner of Excise for the year 2024 with respect to the aforesaid deputation post, prepared by the Adhoc DPC(H) held on 19.12.2024, have also been approved and published by the Government as per the Government Order read as 6th paper above .

- 5. 11 Assistant Commissioners of Excise, who are included in the select list as per the Government order read as 5th paper above, for the years 2023 (Supplementary) and 2024, are eligible for promotion to the cadre of Deputy Commissioners of Excise, with notional effect from the respective date of occurrence of vacancy in the cadre, in continuation to the rearrangement of their seniority in the feeder category Seniority Lists. Sri. Naushad M., Sl. No. 8 in Table-3 (PEN: 205385) has been selected by the DPC(H) dated 19.12.2024 on condition that should any major or minor MoC be issued against him before his promotion to the rank of Deputy Commissioner of Excise, his promotion shall be granted only on provisional basis as per note (i) below rule 28(b)(i)(7) of KS&SSR's for the pendency of the disciplinary action initiated against him. Since no Memo of Charges has been issued against him till date, he is also eligible for getting regular promotion.
- 6. In the above circumstances, the following (Table-3) senior most Assistant Commissioner of Excise included in the supplementary Select List for the years 2023 and Select List for the year 2024 are hereby notionally promoted to the cadre of Deputy Commissioners of Excise with effect from the dates specified in column (7) of Table-3 against their names. The notional promotion will be subject to Rule 23 (c) of Volume I, Part 1 of KSR's.

7. Government also order as follows:

i)Sri.Rakesh.M(PEN 206747), a temporarily promoted Deputy Commissioner of Excise, who has been superseded by the DPC(H) meeting held on 19.12.2024 is reverted to the post of Assistant Commissioner of Excise with immediate effect.

ii). Sri. Vinodkumar.S (PEN: 207733) is eligible for notional promotion to the cadre of Deputy Commissioner of Excise on 01.06.2023. However, since he has only been provisionally selected by the Departmental Promotion Committee (H) dated 19.12.2024, as per note (i) under Rule 28(b)(i)(7) of KS&SSR's, his promotion to the cadre of Deputy Commissioner of Excise is kept as provisional until his selection is formally regularized by the Departmental Promotion Committee(H) to be held in this regard.

8.It is also stipulated that the back arrears of pay and allowances prior to the date on which the incumbents physically assigned the charge in the promoted cadre shall not be admissible to the notionally promoted officers as per rule 23(c), Part I KSR's.

9. The posting orders to the above officers will be issued separately.
