ORDER

The Seniority List of the combined cadre of Circle Inspectors/Managers/Superintendents of Excise for the period from 01.01.2009 to 01.06.2019 has been recast and published as per the Order read as 1st paper above. The Ad hoc Departmental Promotion Committee (Higher) of the Excise Department, which met on 28.11.2024, has revised the Select Lists of Circle Inspectors/Managers/Superintendents of Excise for promotion to the

cadre of Assistant Commissioners of Excise for the year 2021, and also prepared the Select Lists for the years 2022, 2023 & 2024, in accordance with the changes made in the recast feeder category Seniority List of Excise Circle Inspectors. The Select Lists have been approved and published by the Government as per the Government Order read as 3rd paper above. Officers from Sl. Nos. 1 to 4, in the revised Select List for the year 2021 so prepared, had already been included in the finalized Seniority List of Assistant Excise Commissioners for the period from 01.09.2019 to 31.03.2021, published as per Order No. EXC-1609/2021-XD3 dated 04.09.2021 of Excise Commissioner and hence Inspectors/Managers/Superintendents who were included in the revised select list for the year 2021 (from Sl. No. 5 onwards) and select list for the year 2022 were given notional promotion to the cadre of Assistant Commissioner of Excise as per the order read as 5th paper above.

2. 14 officers listed in Table-1 below, who are included in the Select List of Circle Inspectors for the years 2023 and 2024, were granted temporary promotion to the cadre of Assistant Commissioner of Excise as per Rule 31(a)(i) of KS&SSR's. They are eligible for getting regular promotion to the cadre of Assistant Commissioner of Excise, except Sri. Sreenivasan.T.M (PEN: 206965), whose selection has been made only provisionally by the DPC(H) meeting held in 28.11.2024. Hence he is eligible only for provisional promotion as per note (i) Rule 28(b)(i)(7) of KS&SSR's. Remaining 13 officers can be granted notional promotion to the cadre of Assistant Commissioner of Excise.

3. The following officers(Table -2) have been promoted temporarily to the cadre of Assistant Excise Commissioner under Rule 31(a)(i) of Part II of Kerala State and Subordinate Service Rules, 1958. But they were not selected for promotion to the cadre of Assistant Excise Commissioner by the Departmental Promotion Committee (Higher) meeting held on 28.11.2024, and hence are not included in the Select Lists of Circle Inspectors for promotion to the cadre of Assistant Commissioner of Excise, published as per the Government Order read as 3rd paper above.

- 4. Sri. Naushad, I., Sl. No. 90 in the recast seniority list of Excise Circle Inspectors, is eligible for promotion to the cadre of Assistant Commissioner of Excise based on his revised seniority in the feeder category. However, he retired from service on superannuation on 31.05.2023 while still holding the position of Circle Inspector of Excise. The DPC(H) met on 28.11.2024, selected him for promotion to the cadre of Assistant Excise Commissioner, and included as Sl. No. 3 in the Select List for the year 2023, as per the Government Order read as 3rd paper above.
 - 5. 5 vacancies of Assistant Commissioners of Excise and 9 vacancies

of Deputy Commissioners of Excise are at present lying vacant in Excise Department. Select List of Assistant Commissioners of Excise for promotion to the cadre of Deputy Commissioners of Excise, for the years 2023 (supplementary) and 2024, prepared by the DPC(H) held on 19.12.2024, have been approved and published by the Government, as per the Government Order read as 6th paper above. Also, one vacancy of Joint Excise Commissioner is anticipated against the creation of a deputation post of Joint Commissioner of Excise as Technical Officer in the Kerala Toddy Industry Development Board, as per G.O.(Ms) No. 74/2024/Taxes dated 16.11.2024. Select List of Deputy Commissioner for promotion to the cadre of Joint Commissioner, for the year 2024 (supplementary), with respect to the aforesaid deputation post, prepared by the Ad hoc DPC(H) held on 19.12.2024, have also been approved and published by the Government as per the Government order read as 7th paper above. Therefore, in addition to the 14 Circle Inspectors listed in Table-1 who have been temporarily promoted to the cadre of Assistant Commissioners of Excise, 15 more Circle Inspectors are eligible for promotion to the cadre of Assistant Commissioners of Excise. But apart from the 14 numbers of temporarily promoted Assistant Commissioners of Excise, only 14 Circle Inspectors are available in the select list of Circle Inspectors for the years 2023 and 2024 since one officer Sri Naushad. I retired from service on superannuation on 31-05-2023 and hence the anticipatory vacancy that arises in the cadre of Assistant Commissioner of Excise due to the promotion of a Deputy Commissioner of Excise to the cadre of Joint Commissioner of Excise be filled up later after preparing a supplementary select list of Circle Inspectors for the year, 2024.

6. In the above circumstances, the following senior most Circle Inspectors/Managers/Superintendents included in the select lists for the years 2023 and 2024 are hereby notionally promoted to the cadre of Assistant Commissioner of Excise effective from the dates specified in column (7) of Table-3 against their names. The notional promotion will be subject to Rule 23 (c) of Volume I, Part 1 of KSR's.

7. Sri. Sreenivasan T.M. (PEN: 206965) is eligible for notional promotion to the cadre of Assistant Commissioner of Excise on 01.06.2023. However, since he has only been provisionally selected by the Departmental Promotion Committee (H) dated 28.11.2024, as per note (i) under Rule 28(b) (i)(7) of KS&SSR's, his promotion to the cadre of Assistant Commissioner of Excise is kept as provisional until his selection is formally regularized by the Departmental Promotion Committee(H) to be held in this regard.

8.It is also stipulated that the back arrears of pay and allowances prior to the date on which the incumbents physically assigned the charge in the promoted cadre shall not be admissible to the notionally promoted officers as per rule 23(c), Part I KSR's.

9. The posting orders to the above officers will be issued separately.
