ORDER

As per the Govt. Order read above, Administration Sanction was accorded for an amount of Rs.461.33 lakh for the project "Establishment of Value Added Fish Processing Centre in Mulakkuzha Panchayat", under NABARD Tranche XXVIII.

The Director of Fisheries as per the letter read above, furnished the drawal application under Rural Infrastructure Development Fund - Tranche XXVIII, in the prescribed proforma towards the reimbursement claim of the project "Establishment of Value Added Fish Processing Centre in Mulakkuzha Panchayat" for an amount of Rs.13,85,149/- (Rupees Thirteen lakh Eighty Five thousand One Hundred and Forty Nine only), being the expenditure of the project, incurred for the period December 2025 and has requested to accord sanction for the same.
