ORDER

As per the letter read as 1st paper above, Government of India has issued a mother sanction for an amount of ₹56,08,760/- (Rupees Fifty Six Lakh Eight Thousand Seven Hundred and Sixty Only) as Recurring Grant towards Expense to Govt. Medical College, Thiruvananthapuram R G C Thiruvananthapuram (Kerala) under the Centrally Sponsored Scheme “National Programme for Health Care of

the Elderly (NPHCE)” (100%) at Govt. Medical College, Thiruvananthapuram. As per the letter read as 2nd paper above, the Director of Medical Education has requested to allot an amount of ₹56,08,760/- (Rupees Fifty Six Lakh Eight Thousand Seven Hundred and Sixty Only) in SPARSH mode for the above purpose. As per the G.O read as 3rd paper above, Government have additionally authorised an amount of ₹56,09,000/- under the HoA "2210-05-105-63-18-PV" for the release of Central Share for implementing Centrally Sponsored Scheme “National Programme for Health Care of the Elderly (NPHCE)” at Government Medical College, Thiruvananthapuram.
