The Director of Tourism as per paper read 3rd above had accorded sanction for an amount of ₹ 99,90,000/-(Rupees Ninety Nine Lakh and Ninety Thousand only) for the execution of the project 'Maintenance and Beautification of Kappad Blue Flag Beach in Kozhikode District'.

2. The Director of Tourism as per letter read above has submitted the proposal "Maintenance and Beautification of Kappad Blue Flag Beach in Kozhikode District-Phase 2" at an estimated cost of ₹ 4,00,00,000/-(Rupees Four Crore only) to improve the facilities of the blue flag beach so as to attract more tourists into the locality before the Departmental Working Group Meeting on Plan Schemes 2025-26 held on 31.05.2025.

- 7. The Director of Tourism shall ensure that all the procedural and codal formalities and the conditions stipulated in the Government Orders read above are strictly adhered to and the work shall be completed within 12 months.
