ORDER

An amount of Rs.15.00 Lakh was provided under the Head of Account 2215-01-003-99-P(V) for the implementation of the scheme 'Information, Education and Communication (IEC), Capacity Building and Training & Jalasree Club' for the year 2024-25. As per Government Order read as 1st paper above, the estimated cost for the proposed programme is reduced to Rs.10.00 lakh. Subsequently, as per the Government Order read as 2nd paper above, the Administrative Sanction was accorded for the reduced amount of Rs.10.00 lakh. As per the Government Order read as 3rd paper above an amount of Rs.7.5 lakh was released to KRWSA for the implementation of the scheme.

As per the letter read as 5th paper above, the Executive Director, Jalandhi has informed that an amount of Rs.4.54 lakh only could be incurred as expenditure due to the treasury restrictions and accordingly a total amount of Rs.2.96 lakh was resumed by the Government from the four PSTSB Accounts of four Treasuries and requested to release the resumed

fund of Rs.2.96 lakh for the implementation of remaining programmes scheduled during the year 2024-25.

Government have examined the matter in detail and are pleased to release the resumed fund of Rs.2.96 lakh to KRWSA for the implementation of the scheme 'Information, Education and Communication (IEC), Capacity Building and Training & Jalasree Club' (2215-01-003-99-P(V) under State Plan Scheme 2024-25 scheduled during the year 2024-25 subject to the conditions stipulated in the Circular read as 4th paper above.
