An amount of Rs.15.00 Lakh was provided under the Head of Account 2215-01-003-99-P(V) for the implementation of the scheme 'Information, Education and Communication (IEC), Capacity Building and Training & Jalasree Club' for the year 2024-25. As per Government Order read as 1st paper above, the estimated cost for the proposed programme is reduced to Rs.10.00 lakh. Subsequently, as per the Government Order read as 2nd paper above, the Administrative Sanction was accorded for the reduced amount of Rs.10.00 lakh.
