An amount of Rs.1000 Lakh was provided under the Head of Account 2215-01-800-64-P(V) for the implementation of the scheme 'Scaling up of Rain Water Harvesting and Ground Water Recharge programme' for the year 2024-25. As per Government Order read as 2nd paper above, the estimated cost for the proposed programme is reduced to Rs.702.96 lakh. Subsequently, as per the Government Order read as 2nd paper above, the Administrative Sanction was accorded for the reduced amount of Rs.702.96 lakhs.

As per the letter read as 4th paper above, The Executive Director has informed that an amount of Rs.587.68 lakh only could be incurred as expenditure due to the treasury restrictions and accordingly a total amount of Rs.104.78 lakh was resumed by the Government from the four PSTSB Accounts with Treasuries and requested to release the resumed fund of Rs.104.78 lakh for the settlement of payment to contractors in connection with the Scaling up of Rain Water Harvesting and Ground Water Recharge Programme.
