ORDER

As per the G.O read as 1st paper above, In - Principle Administrative Sanction was accorded for the implementation of Kozhikode City Road Improvement Project (KCRIP) Phase II, for a total amount of 1312.679 Crore (Rupees One Thousand Three Hundred and Twelve Crore Sixty Seven Lakh Ninety Thousand)(Rs.720.39,86,449 Crore for LA and Rs.592.281 Crore for Construction) under the H/A 5054-04-337-80(PV), subject to the verification of detailed estimate by the Chief Technical Examiner .

2. As per the letter read above, the CEO, KRFB submitted proposal to accord sanction for releasing the Contingency Charge amounting Rs.150 lakhs for the land acquisition of CWRDM – Panathuthazham flyover, Mananchira - Pavangadu Road, and Kalluthankadav – Meenchantha Road in connection with Kozhikode City Road Improvement Project- Phase II.

Government have examined the matter in detail and are pleased to accord sanction to release an amount of Rs.150 lakh (Rupees One Crore Fifty Lakhs only) as Contingency Charge under the H/A 5054-04-337-80(PV) for LA in connection with the land acquisition of CWRDM – Panathuthazham flyover, Mananchira - Pavangadu Road, and Kalluthankadav – Meenchantha Road in connection with

Kozhikode City Road Improvement Project- Phase II.
