The Chief Engineer, KSTP, vide letter read as 1st above, has submitted a restoration estimate of Rs. 70,05,784/- for arranging the restoration work along MC Road in OFC laid portion from Thycode to Nilamel – from Km 25/250 to Km 45/400 RHS for the rectification of the OFC laid by JIO, the service provider and informed that JIO remitted a total of Rs.7,10,540/- for the HDD method and Rs.63,00,080/- for the open trench method, which will be utilized where HDD is not feasible. The Chief Engineer, Roads, vide letter read as 2nd above, informed that the stretch is in Safe Corridor Demonstration Project (SCDP) maintained by the KSTP and is under maintenance contract. The Chief Engineer requested to accord Administrative Sanction for an amount of Rs. 70,05,784/- for arranging the restoration works.
