**ORDER**

An amount of Rs.15.00 lakh was provided under the Head of Account 2215-01-003-99-P(V) for the implementation of the scheme 'Information, Education and Communication (IEC), Capacity Building and Training & Jalasree Club' for the year 2025-26. Administrative Sanction was accorded for a total amount of Rs.15.00 lakh for the implementation of the scheme in the state as per the Government Order read as 1<sup>st</sup> paper above. Out of this, an amount of Rs.2,96,000/- (Rupees Two lakh ninety six thousand only) which was resumed during the year 2024-25 was sanctioned and released as per Government Order read as 2<sup>nd</sup> paper above.

2.The Executive Director, Jalanidhi , as per the letter read as 3rd paper above, has informed that Rs.2.58 lakh has been expended for the implementation of IEC Programmes and requested to release balance amount Rs. 12,04,000/- (Rupees Twelve lakh four thousand only) in the budget provision for meeting the immediate expenses and for conducting training programme for school teacher coordinators and for execution of other components of the scheme.

3. Government have examined the matter in detail and are pleased to

release Rs 2.29 lakh from the current years provision under the Head of Account 2215-01-003-99-P(V) for implementation of the scheme “Information, Education and Communication (IEC), Capacity Building and Training & Jalasree Club”, subject to the following terms and conditions:

- i. The amount released shall be transfer credited to PSTSB account in compliance of GO(P)62/2018/Fin dated 16/4/2018.
- ii. The instructions in Circular No.84/2008/fin dated 09/12/08, Circular No.82018/fin dated 30/012018 & G.O(Ms) No.93/2020/Fin dated 11.09.2020 shall be scrupulously followed.
- iii. The Administrative Department shall furnish duly authenticated detailed component wise statement of expenditure and Utilization Certificate as per instructions in GO.(Ms)No.4/2020/Fin dated 09/01/2020.
- iv. If there is un-utilized amount at the end of this financial year that should be refunded to the government during the financial year itself.
