ORDER

As per letter read as 2nd paper above, the Chief Engineer, KSRRDA reported that the agreement for the work of PMGSY (2013-14) Phase VIII-Package No.KR-10-28 Palakkayam-Thiruppapathy road in Mannarkkad Block, Palakkad was executed on 12.11.2014 and the work was fully completed for a length of 3.3 Km. But, during the floods in 2018 and 2019, the underside of the road was washed away and a length about 60m land cracked and settled down, causing heavy damages to the road surface which require immediate restoration. Therefore the Chief Engineer has submitted the flood estimate of the work for ₹1,36,49,611.41/- including GST 18% as per PRICE rate and requested to accord Administrative sanction for the restoration estimate.

2.Government have examined the matter in detail and are pleased to accord Administrative Sanction for the restoration estimate for an amount of ₹1,36,49,611/- (Rupees One Crore Thirty Six Lakh Forty Nine Thousand Six Hundred and Eleven only) in connection with the work of PMGSY 2013-14 Phase VIII Package No.KR-10-28 Palakkayam-Thiruppapathy road by meeting the expenditure from the H/A:4515-00-800-98-03 (State Support for PMGSY), subject to the following conditions;

(1) The necessity and requirement of the work shall be ensured by the Chief Engineer, KSRRDA.

- (2) The suitability of CC or RCC retaining wall shall be examined by TS authority considering stability and economy for constructing the proposed retaining wall. The reinforcement design for the RCC retaining wall (if taken up) shall be based on actual structural design, considering economy.
- (3) The competent authority shall ensure the admissibility of provisions with the actual site conditions before issuing the Technical Sanction. The Chief Engineer, KSRRDA should review the use of "(Spec code 3.9.1) Excavation in Hard rock (requiring blasting)" based on site conditions.
