**ORDER**

As per the Government Order read above, Administrative sanction was accorded for the "Second stage Development of Hatchery at Kallanode in Kozhikode District" for an amount of Rs. 1981.00 lakh under NABARD - RIDF Tranche XXVIII.

2) As per the letter read above, the Director of Fisheries has furnished the drawal application under the Rural Infrastructure Development Fund – Tranche XXVIII, in the prescribed proforma, towards the 4th reimbursement claim for the project “Second Stage Development of Hatchery at Kallanode in Kozhikode District,” for an amount of Rs. 55.35227 lakh (Rupees Fifty-Five Lakh Thirty-Five Thousand Two Hundred and Twenty-Seven only), being the expenditure incurred for the project during the period from 01.08.2024 to 31.10.2025.
