ORDER

WHEREAS, it has been disclosed from the records of investigation in Crime No.91/2024 of Valiyathura Police Station that the accused [A1] Abdul Raheem.A, S/o Aboobekkar, Anshitha Manzil, Eaithukondankani, Kollayil, Amaravila P.O, Trivandrum, had obtained Indian Passport bearing No.B 3203088 under the name and address of Shereef Jamal, S/o Jamal, Resident of H and B Colony, 476 Nisha Manzil, Asramam North P.O Kollam and used this fake passport as genuine to travel abroad. Later he renewed the passport as P 4180787. On 22.01.2024, the accused [A1] Abdul Raheem.A arrived at Thiruvananthapuram International Airport from Saudi Arabia by flight No UL-161, using the aforementioned forged passport No P 4180787. Thus the accused [A1] Abdul Raheem.A violated Passport Act and Rules and committed offences punishable under section 419, 465, 468, 471 & 34 of Indian Penal Code, 1860 and section 12(1)(a) & 3 r/w 12(1)(b) of the Indian Passport Act, 1967.

AND WHEREAS, the Government of Kerala after careful examination of the records of investigation in Crime No.91/2024 of Valiyathura Police Station are fully satisfied that the aforesaid accused [A1] Abdul Raheem.A committed offences punishable under section 12(1)(a) and 3 r/w 12(1)(b) of the Passport Act, 1967 along with other offences for which he should be prosecuted.

NOW THEREFORE, Government of Kerala, in exercise of the powers conferred by section 15 of the Passports Act, 1967 read with Government of India Notification No. GSR 662(E), dated 01.12.1979 of the Ministry of External Affairs do hereby, accord sanction to prosecute the accused [A1] Abdul Raheem.A, for the offences punishable under section 12(1)(a) and 3 r/w 12(1)(b) of the Passport Act, 1967, in Crime No.91/2024 of Valiyathura Police Station and for taking cognizance of the said offences by a court of competent jurisdiction.
