**ORDER**

As per the G.O read as 1<sup>st</sup> paper above, Government have released an amount of Rs.27,50,00,000/- (Rupees Twenty Seven Crore Fifty Lakhs) (including Central Share for an amount of Rs.16,50,00,000/- (Rupees Sixteen Crore Fifty Lakhs only) and State Share for an amount of Rs.11,00,00,000/- (Rupees Eleven Crore only) from the HoA "2210-06-101-09-02 (PV)" to National Health Mission. As per the letter read as 2<sup>nd</sup> paper above, the NHM has reported that an amount of Rs.14,52,00,000/- is available under the HoA "2210-06-101-09-01" and has requested to reappropriate an amount of Rs.33,333/- from the HoA "2210-06-101-09-01" to HoA "2210-06-101-09-02" for releasing the amount sanctioned vide the G.O read as 1<sup>st</sup> paper above.

2) As per the G.O read as 3<sup>rd</sup> paper above, Government have accorded sanction for the Re-appropriation for an amount of Rs.34,000/- from the HoA "2210-06-101-09-01" to HoA "2210-06-101-09-02" for the above purpose.

3) Government have examined the matter in detail and are pleased to accord sanction to release an amount of Rs.33,333/- (Rupees Thirty

Three Thousand Three Hundred and Thirty Three only) under the Head of Account " 2210-06-101-09-02" for releasing the amount re-appropriated vide the G.O read as 1<sup>st</sup> paper above.
