ORDER

The Ministry of Rural Development (MoRD), GoI, vide letter read as 2nd paper above, has accorded Mother Sanction for an amount of ₹4,74,37,000/- towards pending claims of second half of FY 2024-25 under the RSETI scheme. The Executive Director, Kudumbashree (implementing agency of RSETI in Kerala), as per letter read as 3rd paper above, has requested to release the same after getting additional authorization against the head of account 2501-06-198-48-17 (100% CSS).

2. Government have examined the matter in detail. As per GO read as 4th paper above, an additional authorization of ₹4,74,37,000/- has been sanctioned. In the above circumstances, Government are pleased to accord sanction to release an amount of ₹4,74,37,000/- (Rupees Four Crore Seventy Four Lakh and Thirty Seven Thousand only) as Mother Sanctioned fund towards pending claims of second half of FY 2024-25 under RSETI scheme from the current year budget by debiting the amount in the head of account 2501-06-198-48-17.

3.The conditions/guidelines/procedures stipulated in the Circular read

as 1st paper above and the letter read as 2nd paper above should strictly be followed and complied with. The controlling officer concerned should take timely steps to regularize the additional authorization as per GO read as 4th paper above through re-appropriation of savings only within the Grant before the close of the current financial year.
